- An estate is represented by all parties to the estate jointly. A party to the estate may give power of attorney to an agent in order for the
 agent to represent them in questions relating to the estate. The original of the power of attorney must be presented.
- Handelsbanken AB and all subsidiaries in the Group, henceforth referred to as "the Bank", reserve the right to determine whether the
 power of attorney will be approved.
- If a party to the estate is resident outside Sweden, the signature of the Principal (party granting power of attorney) must be witnessed by a Notary Public, embassy or consulate.

- 3) close all joint bank accounts which belonged to me and the deceased and distribute the remaining holdings
- be informed of and sell, assign or in any other way dispose of the deceased's holding of mutual fund units and securities registered in custody or securities accounts,
- 5) in conjunction with the selling or transfer of securities registered on a securities account, open a new custody account on behalf of the estate, from which the sale or transfer can take place. The custody account can subsequently be closed,
- 6) receive information from the insurance company concerning the deceased's insurance policies, and sign receipt of insurance compensation payable to myself or the estate,
- 7) receive and sign for funds, documents of value, or other items that may belong to the estate,
- 8) be given access to and take possession of property in the deceased's safe deposit box/service box, and close such services,
- 9) make payments to settle all debts of the estate,
- if the beneficiary is a Handelsbanken customer with approved KYC information, but is lacking the fund accounts to be transferred, Handelsbanken is assigned to open the equivalent fund accounts with Handelsbanken on behalf of the beneficiary. The beneficiary thereby approves the terms and conditions (V100) applying to Trade in Handelsbanken's Non-Complex Funds, and consents to agreements, terms and conditions and fund fact sheets being sent thereafter to the beneficiary's registered address.
- 11) enforce the division of property and distribution of estate agreements, and
- 12) in other respects take any actions necessary to administrate and settle the assets of the estate.

Please note that this power of attorney alone does not give the agent the personal right to receive my share of the assets of the estate, reimburse expenses, or sign division of property or distribution of estate agreements on my behalf. For the agent to be given the aforementioned rights, the agent must prove these rights through a separate power of attorney, or in a separate agreement between the parties to the estate.
