## 1. Handelsbanken's Corporate Package

The Corporate package contains all the solutions needed by limited companies, trading-, limited partnerships and sole traders with extra requirements.

### Fee

The Corporate package is charged annually, currently SEK 1 250 per year. Transaction charges are added according to valid pricelist and are billed separately.

With the Corporate package the company can use the following solutions:

### Online corporate banking\*

The company will be able to perform all the banking transactions and also gain a quick overview of the company's finances. With online corporate banking service the company can perform the following:

- Payments within Sweden, Cross-border payments and Salary payments
- Transfers to accounts in Handelsbanken and other banks
- Account information - balances and transactions
- Electronic documents - storage for 36 months
- File management - send and receive information on file
- Mandates - administer your company's bank mandates
- Access to business services
